Self-Help Services

Superior Court of California, County of Los Angeles



Self-Help provides self-represented litigants with various resources to navigate the judicial process from start to finish. Help is offered by volunteers, paralegals and attorneys. The Superior Court of California, County of Los Angeles currently offers in person self-help services in the following case-types:

Family Law, including Divorce & Paternity

Probate (Guardianship and Conservatorship) Unlawful Detainers (Evictions)

Consumer Debt, including Claims of Exemption

Domestic Violence, including Restraining Orders

Civil Harassment Name Change

Types of Services:

Depending on the case-type and location, Self-Help offers:

- Group workshops and clinics;
- Computer-based and one-on-one assistance to complete required forms;
- Information and guidance on court procedures and requirements;
- Online services including programs for easy completion of some court forms; and
- Referrals to non-profit agencies.

Languages Offered:

All self-help services are offered in both English and Spanish at all our locations. In addition, the Court offers the following:

- Workshops in Armenian in our Pasadena location:
- Workshops in Khmer (Cambodian) in our Long Beach location.

'I-Speak' cards help self-help staff identify other language needs at intake, and services in other languages are available on a limited basis depending on location.



JusticeCorps in Los Angeles County:



- Since 2004, the JusticeCorps program has recruited college students and recent graduates for one year of AmeriCorps service where they provide direct assistance to self-represented litigants in Self-Help centers.
- JusticeCorps currently operates in Los Angeles, the Bay Area, and San Diego.
- In FY 2018/19, JusticeCorps members provided over 132,000 instances of assistance, helped self-represented litigants with over 300,000 court forms, and provided language assistance to over 23,000 limited-English proficient self-represented litigants in Los Angeles County.
